**Re: Amendment to Option Agreement – Bonnie Claire Lithium Project – Nevada, USA (the

The Parties hereby confirm that the Option Agreement, as amended by this Amendment Agreement, remains in full force and effect. Terms used but not defined in this Amendment Agreement shall have the meanings ascribed to such terms in the Option Agreement.

Sections 1.2, 15, 18, 20.2, 20.5, 20.7, 20.8, 20.9, 20.10 and 20.12 of the Option Agreement apply to this Amendment Agreement.


