



**VARIATION AGREEMENT No: 1

**THIS AGREEMENT** is made on 26<sup>th</sup> June 2020

**BETWEEN:**

**BACKGROUND**

- A. Suncorp and the Supplier entered into the Original Agreement.
- B. In consideration of the mutual promises between the parties, Suncorp and the Supplier agree to vary the Original Agreement on the terms of this Agreement.

**AGREEMENT:**

**1. DEFINITIONS IN THIS AGREEMENT**

**Original Agreement** means Order Number CW66911 'Provision of Customer Rewards and Engagement Services' between Suncorp and the Supplier commencing 1<sup>st</sup> of January 2019

**Effective Date** means 1<sup>st</sup> of July 2020 as the date the variations to the Original Agreement as provided in this Agreement will come into effect.

- 1.1 Terms that are defined in the Original Agreement and which are used in this Agreement have the same meaning as that given in the Original Agreement unless this Agreement otherwise requires or permits.
- 1.2 Where there is any inconsistency or conflict between the terms and conditions in this Agreement and the terms and conditions in the Original Agreement, the terms and conditions in this Agreement shall prevail.

**2. VARIATION OF ORIGINAL AGREEMENT**

The Original Agreement is varied and amended as follows:

**2.1 Section 1. Order Details**

1.10 The Service Period is to be replaced with:  
36 months

**2.2 Section 8. Fees and Invoicing**

8.1 Platform Fees to be replaced in its entirety with:  
Suncorp will pay the supplier a monthly fee of \$80,000.

**3. EFFECTIVE DATE OF VARIATION**


The variations to the Original Agreement specified in clause 2 become effective on the Effective Date.


