**Store Card Platform – Club Member Offer Agreement
Letter of Variation**

We hereby confirm our agreement to vary the Agreement, with effect from 28 June 2020, as follows:

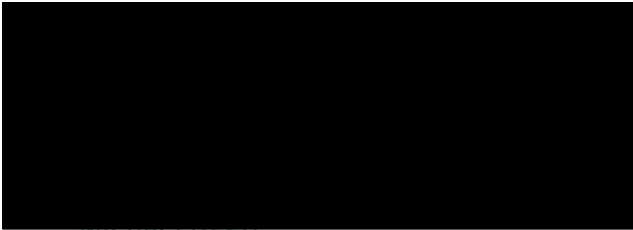
1. by deleting Item 2 in the table in Schedule 1 of the Agreement and replacing it with the following:

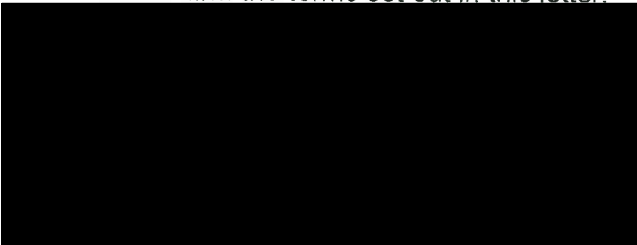

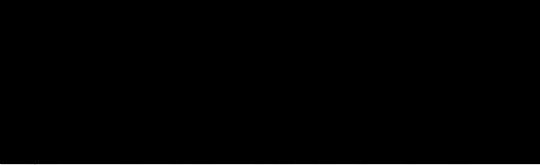
