Bahrey is a director and the CEO & President of the Issuer.  
Global X is a private company owned and controlled by Bahrey.

**2.2 State the date of the transaction or other occurrence that triggered the requirement to file this report and briefly describe the transaction or other occurrence.**

On June 30, 2022, Global X acquired 55,550 units (the “**Units**”) of the Issuer at a price of \$0.30/Unit in the Issuer’s private placement financing. Each Unit is comprised of one StrategX Share and ½ share purchase warrant. Each whole share purchase warrant is exercisable for one StrategX Share at a price of \$0.45 for three years.

Prior to the issuance of these Units, Bahrey owned or controlled 3,986,501 StrategX Shares representing approximately 16% of the outstanding StrategX Shares. Upon issuance of the 55,550 Units, Bahrey now owns or controls 4,042,051 StrategX Shares, representing approximately 14.6% of the outstanding StrategX Shares, on a non-diluted basis.

On a partially diluted basis (assuming the exercise of all 500,000 stock options and 1,027,775 warrants held by Bahrey/Global X), Bahrey would have ownership and control over approximately 19.1% of the then issued StrategX Shares.
