On November 29, 2022, Mr. White acquired 1,504,975 Common Shares pursuant to the voluntarily conversion of 15,049.75 Class A common shares (“**Class A Shares**”) in the capital of the Company, in accordance the terms of the Company’s articles (the “**Conversion**”).

**Item 3 - Interest in Securities of the Reporting Issuer**

3.1 ***State the designation and number or principal amount of securities acquired or disposed of that triggered the requirement to file the report and the change in the acquiror’s securityholding percentage in the class of securities.***

Mr. White acquired 1,504,975 Common Shares in connection with the Conversion. Upon completion of the Conversion, Mr. White’s securityholding percentage in Common Shares increased by 2.97% (from 1.67% to 4.64%). On an as-converted to Common Shares basis (taking

into account the conversion of all outstanding Class A Shares), Mr. White's securityholding percentage in Common Shares was unchanged at 10.87%.

Mr. White acquired ownership of the securities that triggered the requirement to file this report. See Item 2.2 above.

Immediately prior to the Conversion, Mr. White beneficially owned or otherwise exercised control or direction over 806,654 Common Shares, 72,598.91 Class A Shares and 300,000 options to purchase Common Shares ("Options"), representing approximately 14.99% of the issued and outstanding Common Shares (on a partially diluted basis, including the conversion of all Class A Shares held by Mr. White for 7,259,891 Common Shares) as of November 29, 2022.

As a result of the Conversion, Mr. White beneficially owns or otherwise exercises control or direction over 2,311,629 Common Shares, 57,549.16 Class A Shares and 300,000 Options, representing approximately 14.46% of the issued and outstanding Common Shares (on a partially diluted basis, including the conversion of all Class A Shares held by Mr. White for 5,754,916 Common Shares) as of November 29, 2022.

Mr. White voluntarily converted the Class A Shares to Common Shares, for no additional consideration on the basis of one-hundred (100) Common Shares for each one (1) Class A Share pursuant to the Company's articles.
