Immediately following the Sale, Origen was the legal and beneficial owner of 4,097,036 Common Shares, representing approximately 27.9% of the issued and outstanding Common Shares (being 14,692,589 Common Shares). Origen is also the legal and beneficial owner of 5,000,000 Warrants, entitling it to purchase 5,000,000 additional Common Shares of the Issuer.

Assuming exercise of the 5,000,000 Warrants owned by Origen, Origen would be the legal and beneficial owner of 9,097,036 Common Shares, or approximately 46.2% of the issued and outstanding Common Shares of the Issuer (on a partially diluted basis).
