

## PR Technology Launches New Product on Kickstarter January 2023 Bandibul: Wireless LEDs for LEGOs

**VANCOUVER, BC, January 17, 2023** – PR Technology Inc. (CSE: PRTI) (the "**Company**") announces that the Company launched Bandibul on Kickstarter on January 16, 2023. Bandibul is the world's first LEDs for LEGOs powered by wireless power transmission.



Bandibul is powered wirelessly in range of its magnetic resonance base plate whereas most LEDs for LEGOs require electrical wiring or have other technical limitations. The transmitter in the base plate creates a magnetic field that vibrates, and the receiver coils in the LED lights convert the magnetic field into electrical energy. Other key features of Bandibul include that it can power limitless LEDs and, due the small 1x1 size of the LED bricks, they easily fit onto LEGO projects without taking up space.

Bandibul has a wide variety of modes available. 'Blink' and 'Glow' modes set an interval for the LEDs to turn on and off, and there is also a sound response mode which causes the LEDs to flash on and off based on a nearby sound or music.

Bandibul launched on January 16, 2023 on Kickstarter, where Bandibul can be purchased for up to 40% off.

The Company is a technology company with a portfolio of intellectual properties in the wireless power transmission ("WPT") technology industry. The Company has developed a low frequency resonant WPT technology and offers WPT products. The Company, through its wholly-owned subsidiary, PRT Korea Co., Ltd., is primarily focused on the development of its WPT systems for factory automation and rail guided vehicles on the factory floor. The Company is also engaged in developing wireless chargers for mobile devices, wireless charging stations for drones, wireless charging products for home appliances, and wireless LED lights for toys and fish tanks.
