1.1 DATE AND SUBJECT OF REPORT

This Management's Discussion and Analysis (this "MD&A" or "Report") of the financial condition of Talent Infinity Resource Developments Inc. ("Talent" or the "Company") and results of operations of the Company for the period ended February 28, 2023 has been prepared by management in accordance with the requirements under National Instrument 51-102 – *Continuous Disclosure Obligations* as at May 1, 2023. The Report should be read in conjunction with the condensed interim financial statements and related notes thereto of the Company as at and for the three and nine months ended February 28, 2023 and 2022, and the audited consolidated financial statements including the notes thereto for the year ended May 31, 2022 (the "Financial Statements"). The Financial Statements are presented in accordance with International Financial Reporting Standards ("IFRS"), and Talent' accounting policies are described in Note 3 of the Financial Statements. All dollar amounts in the Report are in Canadian dollars unless otherwise noted.

The Financial Statements, together with the MD&A, are intended to provide investors with a reasonable basis for assessing the performance and potential future performance of the Company and are not necessarily indicative of the results that may be expected in future periods. 1.2 OVERVIEW AND DESCRIPTION OF BUSINESS

The Company was incorporated on June 25, 2020 under the laws of British Columbia, Canada. On January 14, 2021, the Company changed its name to Talent Infinity Resource Developments Inc. The Company is engaged in the acquisition, exploration and development of mineral resource properties located in Canada.

The Company's head office and records office is located at and records office is located at 5728 East Boulevard, Vancouver, British Columbia, V6M 4M4.

The Company is engaged in the business of acquiring, exploring and developing natural resource properties with a focus on properties/projects which have the potential for both near-term cash flow and significant exploration upside potential. The Company is considered to be in the exploration stage as it has not placed any mineral properties into production.

Since March 2020, several measures have been implemented in Canada and the rest of the world in response to the increased impact from novel coronavirus (COVID-19). The Company continues to operate its business at this time. While the impact of COVID-19 is expected to be temporary, the current circumstances are dynamic and the impacts of COVID-19 on business operations cannot be reasonably estimated at this time. The Company anticipates this could have an adverse impact on its business, results of operations, financial position and cash flows in 2021.

1.3 OVERALL PERFORMANCE

- The Company had minimal transactions during the period, however expenses were incurred during the year related to the Company's mineral property interests.
- During the period ended February 28, 2023, the Company made a \$50,000 payment on the Option Agreement relating to its interest in the Wildcat property.

Mineral Properties

On June 30, 2020 the Company entered into an option agreement (the "Option Agreement") whereby it can earn a 100% interest (subject to a 2.0% net smelter return royalty "NSR") in 10 mineral claims situated in the Quesnel Terrane area of the Province of British Columbia (the "Wildcat Property"). The interest in the Wildcat Property can be earned where certain requirements are met as set forth within the option agreement. These are further outlined below:

The terms of the option agreement include:

- a) Total payments of \$770,000 to the vendor as follows:
 - i. \$20,000 on or before July 31, 2021 (\$10,000 paid during May 31, 2021 year-end and \$10,000 paid on June 8, 2021)
 - ii. \$50,000 on or before November 30, 2021 (\$25,000 paid on July 8, 2021)
 - iii. \$50,000 on or before the earlier of the second anniversary of the Company becoming publicly traded (the "Listing Date") or November 30, 2022 (paid November 18, 2022)
 - iv. \$250,000 on or before the earlier of the third anniversary of Listing Date or November 30, 2023
 - v. \$400,000 on or before the earlier of the fourth anniversary of the Listing Date or November 30, 2024

The option may be exercised by the company through paying \$770,000 to the vendor in a combination of cash and shares; with a minimum of 25% of the payment in cash (at the option of the vendor the minimum 25% payment may be requested to be made as shares of the company).

Third Round

On August 18, 2021, the Company closed its Third Round of the Private Placement, issuing 12,729,902 common shares at a price of \$0.02 per common share for proceeds of \$254,598. As proceeds for the shares had been received during the year ended May 31, 2021 in respect of the Third Round of the Private Placement, the Company reclassified \$254,598 from Shares to be Issued to Common Shares.

Fourth Round

On August 20, 2021, the Company closed its Fourth Round of the Private Placement, issuing 275,000 common shares at a price of \$0.10 per common share for proceeds of \$27,500. As proceeds for the shares had been received during the year ended May 31, 2021 in respect of the Fourth Round of the Private Placement, the company reclassified \$27,500 from Shares to be Issued to Common Shares.

On August 23, 2021, the Company settled \$75,000 of the loan for the issuance of 750,000 common shares of the company.

For the year ended May 31, 2021:

On June 25, 2020 within the course of incorporation, the Company issued one-hundred common shares for proceeds of \$1 to the incorporator.

During the period ended May 31, 2021, the Company closed on the first and second round of a multiple stage non-brokered private placement (the "Private Placement"). There were no fees paid in respect of the Private Placement.

First Round

On April 26, 2021, the first round of the Private Placement closed and the company raised \$28,826 via issuance of a total of 1,441,316 common shares at a value of \$0.02 per common share.

Second Round

On May 7, 2021, the second round of the private placement closed and the company raised \$95,645 via issuance of a total of 4,782,230 common share at a value of \$0.02 per common share.

As a result of the closing of the first and second round Private Placement, the Company incurred \$123 in share issuance costs.

Shares to be issued

As at May 31, 2021, the Company has received cash of \$254,598 in respect of the third round of the Private Placement, whereby, the Company issued 12,729,902 common shares at a price of \$0.02 per common share on August 18, 2021.

Additionally, as at May 31, 2021, the Company has received cash of \$27,500 in respect of the fourth round of the Private Placement, whereby the company issued 275,000 common shares at a price of \$0.10 per common share on August 20, 2021.

1.5 RESULTS OF OPERATIONS

For the three months ended February 28, 2023

During the three months ended February 28, 2023, the Company reported a loss and comprehensive loss of \$40,821, or \$0.00 per share as compared to a loss and comprehensive loss of \$32,337 or \$0.00 per share during the three months ended February 28, 2022, an increase in the loss and comprehensive loss of \$8,484.

The increase in the loss and comprehensive loss was primarily attributed to the increase in management and consulting fees of \$1,057 (2022 - \$0), professional fees of \$1,617 (2023 - \$28,152 2022 - \$26,535), financing cost associated with the Company's loans payable of \$716 (2023 - \$6,591 2022 - \$5,875) and foreign exchange loss of \$389 (2023 - \$1,024 2022 - \$635), offset by reductions to general and administrative expense of \$1,278 (2023 - \$1,665 2022 - \$2,943), filing fees of \$1,240 (2023 - \$3,446 2022 \$4,686) and increases to interest income of \$401 (2023 - \$1,114 2022 - \$713). Additionally, the increase in the loss was the result of the fact that in the three-month period ended February 28, 2022, the Company had a gain of \$7,624 on the renegotiation and change in terms to one of its loans payable that did not reoccur during the same period in 2023.

Overall, the total loss for the periods ended February 28, 2023, and 2022 was comparable when excluding the gain on the long-term loan that was recorded during the three-month period ended February 28, 2023.

For the nine months ended February 28, 2023

During the nine months ended February 28, 2023, the Company reported a loss and comprehensive loss of \$114,183, or \$0.01 per share as compared to a loss and comprehensive loss of \$165,700 or \$0.01 per share during the nine months ended February 28, 2022. This represents a decrease in the loss and comprehensive loss of \$60,000 when comparing the loss and comprehensive loss for the period ended February 28, 2023 when compared to the same period in 2022.

The decrease in the loss and comprehensive loss was primarily attributed to a decrease in exploration and evaluation expenditure of \$51,251 (2023 - \$37,951, 2022 - \$89,202), a decrease in management and consulting fees of \$12,065 (2023 - \$4,496, 2022 - \$16,561), a decrease in professional fees of \$30,622 (2023 - \$31,632, 2022 - \$62,254) and an increase to interest income of \$2,059 (2023 - \$3,883, 2022 - \$1,824), offset by increases in general and administrative expense of \$1,640 (2023 - \$13,676, 2022 - \$12,036), filing fees of \$3,698 (2023 - \$14,334, 2022 - \$10,636), finance costs of \$13,742 (2023 - \$19,617, 2022 - \$5,875), a decrease in the foreign exchange gain of \$8,509 (2023 - \$3,640, 2022 - \$12,149), and a decrease in the gain on long-term loan of \$16,890 (2023 - nil, 2022 - \$16,890).

The reduction in the loss and comprehensive loss for the nine-month period ended February 28, 2023 when compared to the same period in the prior year was primarily the result of decline in exploration activity on the Company's Wildcat project while it evaluates Phase I exploration results and devises an exploration plan for future phases of exploration on the Wildcat project.

1.7 LIQUIDITY AND CAPITAL RESOURCES

As at February 28, 2023, the Company reported a working capital of \$30,213 (May 31, 2022 - \$170,595) consisting of cash of \$70,644 (May 31, 2022 - \$300,173), prepaid expenses of \$5,000 (May 31, 2022 - \$5,000), receivables of \$2,312 (May 31, 2021 - \$2,077), and government remittances receivable of \$1,935 (May 31, 2022 - nil), less trade payables and accrued liabilities of \$36,226 (May 31, 2022 - \$103,436) and Loans Payable of \$13,542 (May 31, 2022 - \$33,219).

During the period ended February 28, 2023 the company incurred a loss and comprehensive loss of \$114,183 (February 28, 2022 - net loss of \$165,700). As at February 28, 2023, the Company has an accumulated deficit of \$510,137 (May 31, 2022 - \$395,954).

The continuation of the Company as a going concern is dependent upon its ability to raise additional capital or debt financing on reasonable terms in order to meet business objectives towards achieving profitable operations.

1.8 OFF-BALANCE SHEET ARRANGEMENTS

The Company does not utilize off-balance sheet arrangements.

1.9 FINANCIAL INSTRUMENTS AND RISK MANAGEMENT

Early Stage - Need for Additional Funds

The Company has no history of profitable operations and its present business is at an early stage. As such, the Company is subject to many risks common to such enterprises, including undercapitalization, cash shortages and limitations with respect to personnel, financial and other resources and the lack of

revenues. There is no assurance that the Company will be successful in achieving a return on shareholders' investments and the likelihood of success must be considered in light of its early stage of operations. The Company has no source of operating cash flow and no assurance that additional funding will be available to it for further exploration and development of its projects when required. Although the Company has been successful in the past in obtaining financing through the sale of equity securities, there can be no assurance that the Company will be able to obtain adequate financing in the future or that the terms of such financing will be favorable, especially in today's volatile and uncertain financial markets. Failure to obtain such additional financing could result in the delay or indefinite postponement of further exploration and development of its properties.

Exploration and Development

Exploration for minerals is a speculative venture involving substantial risk. There is no certainty that the expenditures made by the Company will result in discoveries of commercial metal reserves. Mining and development risks always accompany anticipated rewards, and uncertainties always exist where mineral properties are concerned. Uncertainties include the size, grade and recovery of naturally occurring mineral deposits. Although exploration and development efforts can outline a mineral deposit with a degree of certainty, ultimate grade and tonnages are never fully known until mining has been completed. Metal prices are also a significant factor in the development decision for a mineral property, as a mine may not be economically feasible in a period of depressed prices. Factors beyond the control of the Company may affect the marketability of any minerals discovered. Pricing is affected by numerous factors such as international economic and political trends, global or regional consumption and demand patterns, and increased production by current producers.

Operating Hazards and Risks

Mining operations involve many risks, which even a combination of experience, knowledge and careful evaluation may not be able to overcome. In the course of exploration, development and production of mineral properties, certain risks, and in particular, unexpected or unusual geological operating conditions including rock bursts, cave-ins, fires, flooding and earthquakes may occur. Operations in which the Company has a direct or indirect interest will be subject to all the hazards and risks normally incidental to exploration, development and production of metals, any of which could result in damage to destruction of mines and other producing facilities, damage to life and property, environmental damage and possible legal liability for any or all damage.

Title Risks

Title to exploration and evaluation assets involves certain inherent risks due to the difficulties of determining the validity of certain claims as well as the potential for problems arising from the frequently ambiguous conveyancing history characteristic of many mineral properties. The Company has investigated title to all of its mineral properties and, to the best of its knowledge, title to all of its properties are in good standing.

Competition and Agreements with Other Parties

The mining industry is intensely competitive in all its phases. The Company competes with other companies that have greater financial resources and technical capacity. Competition could adversely affect the Company's ability to acquire suitable properties or prospects in the future. The Company may, in the future, be unable to meet its share of costs incurred under agreements to which it is a party, and it

may have its interest in the properties subject to such agreements reduced as a result. Also, if other parties to such agreements do not meet their share of such costs, the Company may not be able to finance the expenditures required to complete recommended programs.

Environmental Regulations, Permits and Licenses

The Company's operations are subject to various laws and regulations governing the protection of the environment, exploration, development, production, taxes, labour standards, occupational health and safety, waste disposal, and other matters. Environmental legislation provides for restrictions and prohibitions on spills, releases or emissions of various substances produced in association with certain mining industry operations, such as seepage from tailings disposal areas, which would result in environmental pollution. A breach of such legislation may result in impositions of fines and penalties. In addition, certain types of operations require the submission and approval of environmental impact assessments. Environmental legislation is evolving in a direction of stricter standards, and enforcement, and higher fines and penalties for non-responsibility for companies including its directors, officers and employees. The cost of compliance with changes in governmental regulations has the potential to reduce the profitability for the Company and its directors, officers and employees. The Company intends to fully comply with all environmental regulations. Failure to comply with applicable laws, regulations, and permitting requirements may result in enforcement actions thereunder, including orders issued by regulatory or judicial authorities causing operations to cease or be curtailed, and may include corrective measures requiring capital expenditures, installation of additional equipment, or remedial actions. Parties engaged in mining operations may be required to compensate those suffering loss or damage by reason of mining activities and may have civil or criminal fines or penalties imposed for violations of applicable laws or regulations and, in particular, environmental laws.

Economic Conditions

Unfavorable economic conditions may negatively impact the Company's financial viability as a result of increased financing costs and limited access to capital markets.

Conflicts of Interest

The Company's directors and officers may serve as directors and officers or may be associated with other reporting companies or have significant shareholdings in other public companies. To the extent that such other companies may participate in business or asset acquisitions, dispositions, or ventures in which the Company may participate, the directors and officers of the Company may have a conflict of interest in negotiating and concluding terms respecting the transaction. If a conflict of interest arises, the Company will follow the provisions of the Business Corporations Act, British Columbia ("Corporations Act") in dealing with conflicts of interest. These provisions state, where a director/officer has such a conflict, that the director/officer must at a meeting of the board, disclose his interest and refrain from voting on the matter unless otherwise permitted by the Corporations Act. In accordance with the laws of the Province of British Columbia, the directors and officers of the Company are required to act honestly, in good faith and in the best interests of the Company.

Core Business

The Company's business is focused on the acquisition, exploration and development of mineral resource properties located in Canada.

It will require significant risk and capital for the Company working towards establishing viable business in the sector, if ever. There can be no assurance that the Company ever becomes established or profitable in the sector, even with significant capital investment and business expertise.

Risks Related as a Going Concern

The ability of the Company to continue as a going concern is uncertain and dependent upon its ability to achieve profitable operations, obtain additional capital and receive continued support from its shareholders. Management of the Company will have to raise capital through private placements or debt financing and proposes to continue to do so through future private placements and offerings. The outcome of these matters cannot be predicted at this time.

Reliance on Key Personnel and Advisors

The Company relies heavily on its executive officers and directors, along with key business consultants. The loss of their services would have a material adverse effect on the business of the Company. There can be no assurance that executive officers and key business consultants engaged by the Company will continue to provide services in the employ of, or in a consulting capacity to, the Company or that they will not set up competing businesses or accept positions with competitors.

The Company's risk exposures and the impact on the Company's financial instruments are summarized below:

Foreign exchange risk

Foreign exchange risk is the risk that the value of a financial instrument will fluctuate due to changes in foreign exchange rates. The Company has certain monetary assets denominated in United States Dollars. As at February 28, 2023, the Company had United States Dollar cash on hand with a Canadian dollar equivalent of approximately \$40,169.

Assuming that all other variables remain constant, a fluctuation of +/- 1.0 percent in the exchange rate between the Canadian Dollar and the United States Dollar would impact income before taxes by \$402 as at February 28, 2023.

Credit risk

The Company currently holds its cash at large Canadian financial institutions. The Company does not have any asset-backed commercial paper. The Company intends to maintain cash deposits with a Schedule A financial institution, which from time to time may exceed federally insured limits. The Company has not experienced any significant credit losses and believes it is not exposed to any significant credit risk.

Interest rate risk

Interest rate risk is the risk the fair value or future cash flows of a financial instrument will fluctuate because of changes in market interest rates. Financial assets and liabilities with variable interest rates expose the Company to cash flow interest rate risk. The Company does not hold any financial liabilities with variable interest rates. The Company does maintain bank accounts which earn interest at variable rates but it

does not believe it is currently subject to any significant interest rate risk.

Liquidity risk

The Company's ability to continue as a going concern is dependent on management's ability to raise required funding through future equity issuances and through short-term borrowing. The Company manages its liquidity risk by forecasting cash flows from operations and anticipating any investing and financing activities. Management and the Board of Directors are actively involved in the review, planning and approval of significant expenditures and commitments.

1.10 TRANSACTIONS WITH RELATED PARTIES

The Company entered into the following transactions with related parties:

During the period ended February 28, 2023, the company incurred management and consulting fees to related parties of \$4,496 (2022 - \$16,561).

As at February 28, 2023, the company had amounts payable to a director of the Company of \$1,315 (May 31, 2022 - \$1,315) and an amount receivable of \$2,311 (May 31, 2022 - \$2,076) from a director of the Company.

On July 19, 2021, the Company entered into a term loan agreement (the "Loan Receivable") with a director of the Company (Note 6) whereby the Company loaned \$20,000 to a director of the Company. The Loan Receivable carries an interest rate of 10% per annum and has a fixed term of 24 months. The Loan Receivable was accounted for at amortized cost using the effective interest rate method with the effective interest rate of 15% per annum. The loan was recorded at amortised cost of \$18,146, with reduction of share capital of \$1,854 as capital contribution by a related party. During the period ended February 28, 2023, the Company recorded accretion and interest of \$2,133 on the loan receivable. As at February 28, 2023, the balance of the loan is \$22,667 (May 31, 2022 - \$20,534).
