#### 1.1 DATE AND SUBJECT OF REPORT

This Management's Discussion and Analysis (this "MD&A" or "Report") of the financial condition of Talent Infinity Capital Fund Corporation. ("Talent" or the "Company") and results of operations of the Company for the Quarter ended August 31, 2024 has been prepared by management in accordance with the requirements under National Instrument 51-102 – *Continuous Disclosure Obligations* as at October 30, 2024. The Report should be read in conjunction with the financial statements and related notes thereto of the Company as at and for the periods ended August 31, 2024 and 2023 (the "Financial Statements"). The Financial Statements are presented in accordance with International Financial Reporting Standards ("IFRS"), and Talent's accounting policies are described in Note 3 of the Financial Statements. All dollar amounts in the Report are in Canadian dollars unless otherwise noted.

#### 1.2 OVERVIEW AND DESCRIPTION OF BUSINESS

The Company was incorporated on June 25, 2020 under the laws of British Columbia, Canada. On January 14, 2022 the Company changed its name from Talent Infinity Capital Fund Corporation to Talent Infinity Resource Developments Inc.

The Company's head office and records is located at 5278 E. Boulevard, Vancouver, British Columbia, V6M 4M4. Talent Infinity is a mineral exploration company focused on the acquisition, exploration and development of properties with critical metals such as copper, nickel, cobalt, PGM, zinc, vanadium, and rare earths. The Company is based in Vancouver, B.C. and holds an option over the Wildcat Property, located in the Rainbow Creek Area, 9 km south of the Mt. Milligan mine in North Central B.C. The Company is considered to be in the exploration stage as it has not placed any mineral properties into production.

#### 1.3 OVERALL PERFORMANCE

 The Company had minimal transactions during the period, however expenses were incurred during the year related to the mineral property option agreement. Management of the Company continue to evaluate the next phase of work surrounding the Wildcat project.

#### **Mineral Properties**

On September 13, 2024, the Company executed an amended and restated option agreement (the "Amended and Restated Option Agreement") with the optionor regarding of the Wildcat Property. The optionor has granted the Company the sole and exclusive right for a period of 6 years plus 5 months from the effective date of the original Option Agreement (the Option Period extends through November 30, 2026), to acquire at the election of the Company, an undivided 70% interest in the Wildcat Property. The terms of the restated and amended Option Agreement, include the requirement for the Company to incur \$2,250,000 of exploration expenditures as approved by the author of the National Instrument 43-101 technical report surrounding the Wildcat Property. In addition, the Company must also make option payments to the optionor in the total amount of \$2,070,000 over the term of the option period. The exploration expense and option payment requirements under the amended and restated Option Agreement can be summarized as follows:

#### 1.5 RESULTS OF OPERATIONS

For the three months ended August 31, 2024 and 2023

During the three months ended August 31, 2024, the Company reported a loss and comprehensive loss of \$12,046, or \$0.00 per share as compared to a loss and comprehensive loss of \$15,100 or \$0.00 per share during the three months ended August 31, 2023. This represented a decrease in the loss and comprehensive loss of \$3,054 for the three-month period ended August 31, 2024 versus the same period in the preceding fiscal year.

The decrease in the loss and comprehensive loss was primarily attributable to a decrease in general and office administration expense of \$1,865 (2023 - \$4,498), as well as a reduction in interest income of \$607 (2023 - \$1,068). The decrease in total loss and comprehensive loss period over period was primarily attributed to a decrease in corporate activity as the Company continues to evaluate its mineral property asset.

#### 1.6 LIQUIDITY AND CAPITAL RESOURCES

As at August 31, 2024, the Company reported a working capital deficiency of \$253,778 (May 31, 2024 \$217,182) consisting of cash of \$3,651 (May 31, 2024 - \$5,765), prepaid expenses of \$ 2,296 (May 31, 2024 - \$2,295), receivables of \$6,424 (May 31, 2024 - \$6,295), loan receivable of \$26,691 (May 31, 2024 - \$26,086) less trade payables and accrued liabilities of \$26,729 (May 31, 2024 - \$17,713) and Loans Payable of \$240,683 (May 31, 2024 - \$239,910).

During the period ended August 31, 2024, the company incurred a loss and comprehensive loss of \$12,046 (August 31, 2024 – net loss and comprehensive loss of \$15,100). As at August 31, 2024, the Company has an accumulated deficit of \$615,687 (May 31, 2024 - \$603,641).

The continuation of the Company as a going concern is dependent upon its ability to raise additional capital or debt financing on reasonable terms in order to meet business objectives towards achieving profitable operations.

#### 1.7 OFF-BALANCE SHEET ARRANGEMENTS

The Company does not utilize off-balance sheet arrangements.

#### 1.8 FINANCIAL INSTRUMENTS AND RISK MANAGEMENT

#### Early Stage - Need for Additional Funds

The Company has no history of profitable operations and its present business is at an early stage. As such, the Company is subject to many risks common to such enterprises, including undercapitalization, cash shortages and limitations with respect to personnel, financial and other resources and the lack of revenues. There is no assurance that the Company will be successful in achieving a return on shareholders' investments and the likelihood of success must be considered in light of its early stage of operations. The Company has no source of operating cash flow and no assurance that additional funding will be available to it for further exploration and development of its projects when required. Although the Company has been successful in the past in obtaining financing through the sale of equity securities, there can be no assurance that the Company will be able to obtain adequate financing in the future or that the terms of such financing will be favorable, especially in today's volatile and uncertain financial markets. Failure to obtain such additional financing could result in the delay or indefinite postponement of further exploration and development of its properties.

#### **Exploration and Development**

Exploration for minerals is a speculative venture involving substantial risk. There is no certainty that the expenditures made by the Company will result in discoveries of commercial metal reserves. Mining and development risks always accompany anticipated rewards, and uncertainties always exist where mineral properties are concerned. Uncertainties include the size, grade and recovery of naturally occurring mineral deposits. Although exploration and development efforts can outline a mineral deposit with a degree of certainty, ultimate grade and tonnages are never fully known until mining has been completed. Metal prices are also a significant factor in the development decision for a mineral property, as a mine may not be economically feasible in a period of depressed prices. Factors beyond the control of the Company may affect the marketability of any minerals discovered. Pricing is affected by numerous factors such as international economic and political trends, global or regional consumption

and demand patterns, and increased production by current producers.

#### **Operating Hazards and Risks**

Mining operations involve many risks, which even a combination of experience, knowledge and careful evaluation may not be able to overcome. In the course of exploration, development and production of mineral properties, certain risks, and in particular, unexpected or unusual geological operating conditions including rock bursts, cave-ins, fires, flooding and earthquakes may occur. Operations in which the Company has a direct or indirect interest will be subject to all the hazards and risks normally incidental to exploration, development and production of metals, any of which could result in damage to destruction of mines and other producing facilities, damage to life and property, environmental damage and possible legal liability for any or all damage.

#### **Title Risks**

Title to exploration and evaluation assets involves certain inherent risks due to the difficulties of determining the validity of certain claims as well as the potential for problems arising from the frequently ambiguous conveyancing history characteristic of many mineral properties. The Company has investigated title to all of its mineral properties and, to the best of its knowledge, title to all of its properties are in good standing.

# **Competition and Agreements with Other Parties**

The mining industry is intensely competitive in all its phases. The Company competes with other companies that have greater financial resources and technical capacity. Competition could adversely affect the Company's ability to acquire suitable properties or prospects in the future. The Company may, in the future, be unable to meet its share of costs incurred under agreements to which it is a party, and it may have its interest in the properties subject to such agreements reduced as a result. Also, if other parties to such agreements do not meet their share of such costs, the Company may not be able to finance the expenditures required to complete recommended programs.

#### **Environmental Regulations, Permits and Licenses**

The Company's operations are subject to various laws and regulations governing the protection of the environment, exploration, development, production, taxes, labour standards, occupational health and safety, waste disposal, and other matters. Environmental legislation provides for restrictions and prohibitions on spills, releases or emissions of various substances produced in association with certain mining industry operations, such as seepage from tailings disposal areas, which would result in environmental pollution. A breach of such legislation may result in impositions of fines and penalties. In addition, certain types of operations require the submission and approval of environmental impact

assessments. Environmental legislation is evolving in a direction of stricter standards, and enforcement, and higher fines and penalties for non-responsibility for companies including its directors, officers and employees. The cost of compliance with changes in governmental regulations has the potential to reduce the profitability for the Company and its directors, officers and employees.

The Company intends to fully comply with all environmental regulations. Failure to comply with applicable laws, regulations, and permitting requirements may result in enforcement actions thereunder, including orders issued by regulatory or judicial authorities causing operations to cease or be curtailed, and may include corrective measures requiring capital expenditures, installation of additional equipment,

or remedial actions. Parties engaged in mining operations may be required to compensate those suffering loss or damage by reason of mining activities and may have civil or criminal fines or penalties imposed for violations of applicable laws or regulations and, in particular, environmental laws.

#### **Economic Conditions**

Unfavorable economic conditions may negatively impact the Company's financial viability as a result of increased financing costs and limited access to capital markets.

#### **Conflicts of Interest**

The Company's directors and officers may serve as directors and officers or may be associated with other reporting companies or have significant shareholdings in other public companies. To the extent that such other companies may participate in business or asset acquisitions, dispositions, or ventures in which the Company may participate, the directors and officers of the Company may have a conflict of interest in negotiating and concluding terms respecting the transaction. If a conflict of interest arises, the Company will follow the provisions of the Business Corporations Act, British Columbia ("Corporations Act") in dealing with conflicts of interest. These provisions state, where a director/officer has such a conflict, that the director/officer must at a meeting of the board, disclose his interest and refrain from voting on the matter unless otherwise permitted by the Corporations Act. In accordance with the laws of the Province of British Columbia, the directors and officers of the Company are required to act honestly, in good faith and in the best interests of the Company.

#### **Core Business**

The Company's business is focused on the acquisition, exploration and development of mineral resource properties located in Canada.

It will require significant risk and capital for the Company working towards establishing viable business in the sector, if ever. There can be no assurance that the Company ever becomes established or profitable in the sector, even with significant capital investment and business expertise.

#### Risks Related as a Going Concern

The ability of the Company to continue as a going concern is uncertain and dependent upon its ability to achieve profitable operations, obtain additional capital and receive continued support from its shareholders. Management of the Company will have to raise capital through private placements or debt financing and proposes to continue to do so through future private placements and offerings. The outcome of these matters cannot be predicted at this time.

# Reliance on Key Personnel and Advisors

The Company relies heavily on its executive officers and directors, along with key business consultants. The loss of their services would have a material adverse effect on the business of the Company. There can be no assurance that executive officers and key business consultants engaged by the Company will continue to provide services in the employ of, or in a consulting capacity to, the Company or that they will not set up competing businesses or accept positions with competitors.

#### Foreign exchange risk

Foreign exchange risk is the risk that the value of a financial instrument will fluctuate due to changes in foreign exchange rates. The Company has certain monetary assets denominated in United States Dollars. As at August 31, 2024, the Company had United States Dollar cash on hand with a Canadian dollar equivalent of approximately \$372.

Assuming that all other variables remain constant, a fluctuation of +/- 1.0 percent in the exchange rate between the Canadian Dollar and the United States Dollar would impact income before taxes by \$4 as at August 31, 2024.

#### Credit risk

The Company currently holds its cash at large Canadian financial institutions. The Company does not have any asset-backed commercial paper. The Company intends to maintain cash deposits with a Schedule A financial institution, which from time to time may exceed federally insured limits. The Company has not experienced any significant credit losses and believes it is not exposed to any significant credit risk.

#### Interest rate risk

Interest rate risk is the risk the fair value or future cash flows of a financial instrument will fluctuate because of changes in market interest rates. Financial assets and liabilities with variable interest rates expose the Company to cash flow interest rate risk. The Company does not hold any financial liabilities with variable interest rates. The Company does maintain bank accounts which earn interest at variable rates but it does not believe it is currently subject to any significant interest rate risk.

#### Liquidity risk

The Company's ability to continue as a going concern is dependent on management's ability to raise required funding through future equity issuances and through short-term borrowing. The Company manages its liquidity risk by forecasting cash flows from operations and anticipating any investing and financing activities. Management and the Board of Directors are actively involved in the review, planning and approval of significant expenditures and commitments.

#### 1.9 TRANSACTIONS WITH RELATED PARTIES

The Company entered into the following transactions with related parties:

During the period ended August 31, 2024, the company incurred management and consulting fees to related parties of \$1,056 (2023 - \$1,056).

As at August 31, 2024, the company had amounts payable to directors of the Company of \$5,075 (May 31, 2023 - \$4,018) and an amount receivable of \$2,311 (May 31, 2024 – \$2,311) from a director of the Company.

On July 19, 2021, the Company entered into a term loan agreement (the "Loan Receivable") with a director of the Company whereby the Company loaned \$20,000 to a director of the Company. The Loan Receivable carried an interest rate of 10% per annum and had a fixed term of 24 months. The Loan Receivable was accounted for at amortized cost using the effective interest rate method with the effective interest rate of 15% per annum. The loan was recorded at amortised cost of \$18,146, with reduction of share capital of \$1,854 as capital contribution by a related party. Upon the maturity date of the Loan

Receivable on July 19, 2023, Loan Receivable became a loan with an interest rate of 10% per annum, unsecured and due on demand (the "Loan Receivable #2"). During the year ended May 31, 2024, the Company recorded accretion and interest income of \$2,684 (2023 - \$2,868). As at May 31, 2024, the Loan Receivable #2 had an outstanding balance of \$26,086 (2023 - \$23,402), which was classified as current assets on a statement of financial position. For the period ended August 31, 2024, the Company recognized accretion and interest income of \$605, and the outstanding balance of the Loan Receivable for the period then ended was \$26,691, The Loan Receivable remained classified as a current asset on the statement of financial position for the period ended August 31, 2024.

#### 1.10 SUBSEQUENT EVENTS

There are no subsequent events.
