On May 15 and 16, 2023, Mr. Stéphane Leblanc, President, CEO and shareholder of the Corporation, disposed a total of 327,000 Shares (the “Shares Disposed”) on the public market (the “Disposition”).

The Shares Disposed represent approximately 3.03% of the issued and outstanding shares of the Corporation on non-diluted basis. Prior to the date of the Disposition, Mr. Leblanc, directly and indirectly, held 2,558,165 Shares of the Issuer and convertible securities entitles him to acquire 1,095,000 Shares (the “Convertible Securities”).

Immediate after giving effect to the Disposition, Mr. Leblanc owns or controls, directly or indirectly, 2,231,165 Shares, 350,000 stock options and 745,000 share purchase warrants representing approximately 20.66% of the outstanding shares of the Corporation and 27.96% of the outstanding shares on a partially diluted basis, assuming exercises of the Convertible Securities.

Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Leblanc may develop such plans or intentions in the future.
