# **GEOLOGICAL SERVICES AGREEMENT**

Between

# BRITTEN GEOLOGICAL/EXPLORATION CONSULTANT (The Contractor)

And

Acme Gold Company Limited (The Client)

### BACKGROUND

A. The Client is of the opinion that the Contractor has the necessary qualifications, experience and abilities to provide services to the Client.

B. The Contractor is agreeable to providing such services to the Client on the terms and conditions set out in this Agreement.

In Consideration of the matters described above the Client and the Contractor (the "Parties") agree as follows:

### SERVICES PROVIDED

1. The Client herby agrees to engage the Contractor to provide the Client with services as listed on Schedule A, Scope of Works.

2. The Services will also include any other tasks which the "Parties" may agree on and the Contractor hereby agrees to provide such Services to the Client.

### TERM OF AGREEMENT

3. The Term of the Agreement will begin on March 8, 2021 and will remain in full force and effect until the completion of the Services. The Term may be extended with the written consent of the Parties.

#### CURRENCY

4. Except otherwise provided in this Agreement all monetary amounts referred to in the Agreement are in CAD (Canadian Dollars).

#### COMPENSATION

5. The Contractor will charge the Client a per diem fee of \$650 per day for the Services.

6. The Client will pay the Contractor for GST imposed on the Services provided to the Client under this Agreement. The Client will not withhold any employment related taxes and deductions and the Contractor is responsible for managing all such taxes and deductions.

Payment for compensation to Britten Geological Exploration Consultant (GST account # [redacted for confidentiality reasons]).

## **REIMBURSEMENT OF EXPENSES**

7. Should travel be necessary, all travel must be pre-approved by the Client and the Client will reimburse the Contractor for all reasonable and substantiated expenses necessarily incurred by the Contractor in performance of the work under this Agreement.

8. The Contractor will be reimbursed from time to time for reasonable and necessary expenses incurred by the Contractor in connection with providing the Services and all expenses to be preapproved by the Client.

Reimbursement of expenses to Ronald M. Britten.

### INSURANCE

9. The Contractor shall provide their own Work Safe BC (Worker's Compensation Coverage) for the duration of this Agreement.

### CONFIDENTIALITY

10. Confidential information refers to any data or information relating to the Client, whether business or personal, which would reasonably be considered to be private or proprietary to the Client and that is not generally known and where the release of that Confidential information could be reasonably expected to cause harm to the Client.

11. The Contractor agrees not to disclose, divulge, reveal, report or use, for any purpose, any Confidential information which the Contractor has obtained, except as authorized by the Client or as required by law. The obligations of confidentiality will apply during the Term of this Agreement and will survive indefinitely upon termination of this Agreement.

12. All written and oral information and material disclosed or provided by the Client to the Contractor under this Agreement is Confidential Information regardless of whether it was provided before or after the date of this Agreement or how it was provided to the Contractor.

## AUTONOMY

12. The Contractor will have full control over working time, methods and decision making in relation to provision of the Services in accordance with this Agreement. The Contractor will work autonomously and not at the direction of the Client. However, the Contractor will be responsive to the reasonable needs and concerns of the Client.

This Geological Services Agreement constitutes the entire agreement between the Parties and by signing this Agreement, the Parties agree to be bound by its terms.

#### Services Provided:

Compile data for the exploration program, plan/organize field program to include permitting, logistics/assistant, geophysical airborne survey, proposal/contracting, geological mapping and evaluation of geophysical survey to be recorded and interpreted in a final written report as soon as geochemical data, staining and petrology are completed.

#### **Deliverables:**
