Common shares of Atco Mining Inc. (the “**Issuer**”), head office located at Suite 2200, 885 West Georgia Street, Vancouver, British Columbia, V6C 3E8.

This report is filed in respect of the acquisition of common shares of the Issuer through the initial public offering (“**IPO**”) of the Issuer on the Canadian Securities Exchange.

The acquiror is Transcend Capital Inc. (“**Transcend**”), head office located at Suite 303, 750 West Pender Street, Vancouver, British Columbia.

On October 25, 2022 Transcend acquired 1,830,000 common shares of the Issuer.

Transcend acquired control and direction over 1,830,000 common shares in the capital of the Issuer, representing approximately 7.18% of the Issuer’s current issued and outstanding common shares.

Transcend acquired control and direction over the common shares that are the subject of this report.

Following completion of the IPO, Transcend has control and direction over 3,430,001 common shares of the Issuer, representing approximately 13.45% of the current issued and outstanding common shares of the Issuer.

Transcend has control and direction over 3,430,000 common shares of the Issuer, representing approximately 13.45% of the current issued and outstanding common shares of the Issuer.
