# MOSS GENOMICS INC.

Management Discussion and Analysis For the three months ended September 30, 2023 and 2022 (Expressed in Canadian Dollars) This management's discussion and analysis ("MD&A") is management's interpretation of the financial condition and results of operations of Moss Genomics Inc. ("Moss" or the "Company") for the three months ended September 30, 2023 and 2022. This MD&A should be read in conjunction with the condensed consolidated interim financial statements of the Company for the three months ended September 30, 2023 and 2022, and the audited consolidated financial statements for the year ended June 30, 2023 and 2022, prepared in accordance with International Financial Reporting Standards ("IFRS") as issued by the International Accounting Standards Board ("IASB"). This MD&A complements and supplements, but does not form part of, the Company's financial statements.

All forward-looking statements, including those not specifically identified herein, are made subject to cautionary language contained herein. Readers are advised to refer to the cautionary language when reading any forward-looking statements. All dollar amounts contained herein are expressed in Canadian dollars unless otherwise indicated. ## **OVERALL PERFORMANCE**

# **Background**

Moss was incorporated under the British Columbia Business Corporations Act on September 25, 2018. The head office of the Company is located at Suite 907 – 1030 West Georgia Street, Vancouver, British Columbia, V6E 2Y3 and the registered and records office of the Company is located at Suite 2200 – 885 West Georgia Street, Vancouver, British Columbia, V6C 3E8.

On January 19, 2023, the Company received final receipt from the British Columbia Securities Commission of the Company's Long Form Prospectus dated January 19, 2023 and the Company's common shares were listed on the Canadian Securities Exchange ("CSE") under the trading symbol "MOSS".

As at September 30, 2023, the Company had \$5,213 (June 30, 2023 - \$17,587) in cash and the Company's current liabilities exceeded its current assets by \$36,967 (June 30, 2023 current assets exceed current liabilities by \$9,269). During the three months ended September 30, 2023, the Company incurred a net and comprehensive loss of \$57,210 (2022 - \$100,095).

On October 30, 2023, 200,000 share purchases warrants were exercised for gross proceeds of \$20,000.

On February 22, 2023 the Company granted incentive stock options to certain directors, officers and consultants to acquire 1,320,000 common shares of the Company at a price of \$0.10 per share, vesting immediately and expiring on February 22, 2028.

On September 7, 2022, 450,000 share purchase warrants were exercised for gross proceeds of \$45,000.

As at September 30, 2023, the Company has not paid any cash dividends on its common shares nor does it have any present intention of paying cash dividends on its common shares, as it anticipates that all available funds for the foreseeable planning horizon will be invested to finance its business activities. The Company had accumulated losses of \$1,534,344 (June 30, 2023 - \$1,477,134) since inception, such conditions indicate the existence of a material uncertainty that casts significant doubt about the Company's ability to continue as a going concern.

#### **RESULTS OF OPERATIONS**

# Three months ended September 30, 2023, and 2022

For the three months ended September 30, 2023 and 2022, the Company reported net losses of \$57,210 and \$100,095 respectively. The decrease in loss was primarily driven by a significant decrease in consulting fees incurred, as well as a decrease in marketing fees as a result of a higher advertising and promotional activity in the comparative period and cash conservation efforts in the current period.

## LIQUIDITY AND CAPITAL RESOURCES

The Company reported negative working capital of \$36,967 as at September 30, 2023 (June 30, 2023 positive working capital - \$9,269), which includes a cash balance of \$5,213 (June 30, 2023 - \$17,587).

Current liabilities as at September 30, 2023 consisted of accounts payable of \$47,319 (June 30, 2023 - \$50,466) and accrued liabilities of \$20,458 (June 30, 2023 - \$33).

There is no assurance that the Company will identify an appropriate business for acquisition or investment, and even if so identified and warranted, it may not be able to finance such an acquisition or investment. As such, the Company's business involves a high degree of risk.

Additional funds will be required to enable the Company to pursue such an initiative and the Company may be unable to obtain such financing on terms which are satisfactory to it. Furthermore, there is no assurance that the Company will be profitable. Management intends to finance operating costs over the next twelve months with loans from directors and companies controlled by directors and/or private placement of common shares. These conditions indicate the existence of a material uncertainty that casts significant doubt about the Company's ability to continue as a going concern. As such, it is no guarantee that the Company may continue to operate into the future with the necessary working capital, and it is a clear risk that the liquidity situation of the Company may not remain adequate in order to continue working with suppliers and meeting its liabilities and financial obligations. Due to this fact, the Company recognizes that there is a significant risk around the sufficiency of cash and cash equivalents both now and looking into the future.

#### **OFF-BALANCE SHEET ARRANGEMENTS**

The Company had no off-balance sheet arrangements as at September 30, 2023, June 30, 2023 or as at the date hereof.

#### TRANSACTIONS WITH RELATED PARTIES

Key management personnel include those persons having authority and responsibility for planning, directing, and controlling the activities of the Company as a whole. The Company has determined that key management personnel consists of members of the Board and corporate officers, including the Company's Chief Executive Officer and Chief Financial Officer.

During the three months ended September 30, 2023, the Company incurred consulting fees for key management remuneration of \$Nil (2022 - \$29,387) with the Company's Chief Executive Officer ("CEO"). During the three months ended September 30, 2023, stock-based compensation of \$Nil was paid to the CEO of the Company. As at September 30, 2023, the Company had \$12,325 (June 30, 2023 - \$11,499) due to the CEO.

During the three months ended September 30, 2023, the Company recorded consulting fees for key management remuneration of \$Nil with the President and interim CFO of the Company (2022 - \$11,755). During the three months ended September 30, 2023, stock-based compensation of \$Nil was paid to the President and CFO of the Company. As at September 30, 2023, the Company had \$Nil (June 30, 2023 - \$Nil) due to the President and interim CFO.

During the three months ended September 30, 2023, the Company incurred office and miscellaneous expenses of \$Nil (2022 - \$309) from an entity controlled by a director of the Company. As at September 30, 2023, the Company owed \$Nil (2022 - \$39) to the entity, included in accounts payable and accrued liabilities.

During the three months ended September 30, 2023 and 2022 there was no, stock-based compensation incurred relating to directors, officers, and members of the Board of Directors.

These transactions are in the normal course of the operations on normal commercial terms and conditions, which is the amount of consideration established and agreed to by the related parties.

# Fair value information

The fair values of the Company's cash approximate their carrying amounts due to the short-term nature of these instruments.

IFRS 7 *Financial Instruments: Disclosures* establishes a fair value hierarchy that reflects the significance of inputs used in measuring fair value as follows:

Level 1 – quoted prices (unadjusted) in active markets for identical assets or liabilities;

Level 2 – inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly (i.e., as prices) or indirectly (i.e., derived from prices); and

Level 3 – inputs for the asset or liability that are not based on observable market data (unobservable inputs).

At September 30, 2023 and June 30, 2023, the Company had no financial assets measured and recognized on the statement of financial position at fair value belonging in Level 2 or Level 3 of the fair value hierarchy.

#### Financial instrument risk exposure

The Company's financial instruments expose the Company to certain financial risks, including credit risk, liquidity risk, interest rate risk and foreign currency risk.

#### Credit risk

Credit risk is the risk that one party to a financial instrument will fail to discharge an obligation and cause the other party to incur a financial loss. The Company's primary exposure to credit risk is on its cash. This risk is managed by using major banks that are high credit quality financial institutions as determined by rating agencies. The Company assessed credit risk as low.

# Liquidity risk

Liquidity risk is the risk that the Company will not be able to meet its financial obligations as they fall due. The Company's liquidity and operating results may be adversely affected if its access to the capital market is hindered. The Company did not have sufficient cash to meet its current liabilities at September 30, 2023, therefore the Company has assessed liquidity risk as high.

#### Foreign exchange risk

Foreign exchange risk is the risk that the Company's financial instruments will fluctuate in value as a result of movements in foreign exchange rates. The Company is exposed to foreign exchange risk on its accounts payable denominated in US dollars.

As at September 30, 2023 and June 30, 2023, the Company had exposure to foreign currency risk through the following assets and liabilities denominated in US Dollars:

Based on the above net exposures a 5% change in the Canadian Dollar/US Dollar exchange rate would impact the Company's net loss by approximately \$633 (June 30, 2023 - \$713). As at September 30, 2023 and June 30, 2023 the Company has not hedged its exposure to currency fluctuations. The Company assessed its financial currency risk as moderate as at September 30, 2023 and June 30, 2023.

#### Interest rate risk

Interest rate risk is the risk that the fair value of future cash flows of a financial instrument will fluctuate because of changes in market interest rates. The Company does not currently hold any interest-bearing loans. The Company assessed interest rate risk as low.

# PROPOSED TRANSACTIONS

At the time of this report, the Company is not contemplating any proposed transactions.

#### NEW ACCOUNTING STANDARDS AND ACCOUNTING STANDARDS NOT YET EFFECTIVE

During the three months ended September 30, 2023, the Company did not adopt any new accounting policies.

## **RISKS AND UNCERTAINTIES**

There is no assurance that the Company will be able to finance its operations. As such, the Company's business involves a high degree of risk. Additional funds will be required to enable the Company to pursue such an initiative and the Company may be unable to obtain such financing on terms which are satisfactory to it. Furthermore, there is no assurance that the Company will be profitable. Management intends to finance operating costs over the next twelve months with loans from directors and companies controlled by directors and/or private placement of common shares. These conditions indicate the existence of a material uncertainty that casts significant doubt about the Company's ability to continue as a going concern.

The authorized capital of Moss consists of an unlimited number of common shares without par value. As at the date of this MD&A, there were 44,727,000 common shares, 1,120,000 stock options and 4,800,000 common share purchase warrants issued and outstanding.
