INTRODUCTION

This Management Discussion and Analysis ("MD&A") of Planet Green Metals Inc. (the "Company" or "Planet Green" formerly Forza Lithium Corp. provides analysis of the Company's financial results for the three months ended July 31, 2024 and should be read in conjunction with the accompanying unaudited consolidated financial statements and the notes thereto for the three months ended July 31, 2024 which are available on SEDAR at www.sedarplus.ca.

OVERVIEW

Planet Green Metals Inc. formerly Forza Lithium Corp was incorporated on March 3, 2022, under the Business Corporations Act of British Columbia. The Company changed its name on April 9, 2024 from Forza Lithium Corp. to Planet Green Metals Inc. The address of the Company's corporate office and principal place of business is 9285 – 203B Street, Langley, British Columbia, V1M 2L9.

The Company is in the exploration stage and its principal business activity is the sourcing and exploration of resource properties.

The Company is in the process of exploring its principal resource properties in Ontario and has not yet determined whether the property contains ore reserves that are economically recoverable.

The Company incurred a net loss of \$218,083 for the period ended July 31, 2024 (\$501,551 October 31, 2023) and has an accumulated deficit of \$1,526,746 as at July 31, 2024 (October 31, 2023 - \$792,051), which has been funded primarily by the issuance of equity. The Company's ability to continue as a going concern is uncertain and is dependent upon the generation of profits from resource properties, obtaining additional financing or maintaining continued support from its shareholders and creditors. In the event that additional financial support is not received, or operating profits are not generated, the carrying values of the Company's assets may be adversely affected. These factors indicate the existence of a material uncertainty that may cast significant doubt about the Company's ability to continue as a going concern.

Results of Operations for the three months ended July 31, 2024

During the three-month period, a total of \$400 (2023 - \$124,003) was incurred on the Jeanette Property in Ontario for technical report preparation and logistics.

During the three-month period, \$320 expenses were incurred on the Harrison Road Property (2023- \$Nil) for technical report preparation.

During the three-month period, the Company entered into an option agreement on four properties:

- 1) The Grenfell Property, during the three-month period no expenses were incurred on the property.
- 2) The Marion Property, during the three-month period \$320 expenses were incurred on the property for technical report.
- 3) The Sheraton Property, during the three-month period \$160 expenses were incurred on the property for technical report.
- 4) The Rich Lake Property, no expenses were incurred on the property.

The first partial payment on the optioned properties were: the Grenfell Property partial first payment \$4,500, the Marion Property partial first payment \$5,625, the Sheraton Property partial first payment \$4,500, the Rich Lake Property partial first payment \$3,375.

The Company also incurred \$122,383 (2023 - \$181,425) in operating costs the majority of which were for professional and management fees, general administrative costs for a net loss of \$218,083 (2023 - \$305,428) for the three-month period.

On March 25, 2024, the Forza Lithium Corp. completed the acquisition of 100% of all the issued and outstanding common shares of Planet Green Metals Inc.

Pursuant to the Acquisition Agreement, Forza Lithium Corp. purchased all the issued and outstanding common shares of Planet Green Metals Inc. from Planet Green Metals Inc. shareholders. As consideration, the Company issued 11,300,000 common shares of Forza Lithium Corp. to the shareholders of Planet Green Metals Inc. The Payment Shares will be subject to a hold period of four months plus one day from the date of completion of the Transaction. Additionally, 9,050,000 of the Payment Shares will be subject to a voluntary Pooling Agreement. 20% of the pooled Payment Shares will be released on each of June 26, 2024, December 26, 2024, June 26, 2025, December 26, 2025, and June 26, 2026.

LIQUIDITY AND CAPITAL RESOURCES

As at July 31, 2024, the Company had working capital of \$(34,729) (October 31, 2023 - \$88,666). The Company has no source of operating income and has no assurance that additional funding will be available to it for future exploration and development of its projects, although the Company has been successful in the past in financing its activities through the sale of equity securities. The ability of the Company to arrange additional financing in the future will depend, in part, on the prevailing capital market conditions and exploration success.

CHANGES IN ACCOUNTING POLICIES AND UPCOMING POLICIES

The Company has performed an assessment of new standards issued by the IASB that are not yet effective. The Company has assessed that the impact of adopting these accounting standards on its financial statements would not be significant.

OFF-BALANCE SHEET ARRANGEMENT

As of the date of this filing, the Company does not have any off-balance sheet arrangements that have, or are reasonably likely to have, a current or future effect on the results of operations or financial condition of the Company including, without limitation, such considerations as liquidity and capital resources that have not previously been discussed.

RESOURCE PROPERTIES

a) Jeanette Lithium Property

On March 23, 2022, and as amended on January 9, 2023, the Company entered into an Option Agreement with Gravel Ridge Resources Ltd. And 1544230 Ontario Inc. (collectively, the "Optionors"), pursuant to which the Company has the right to acquire a 100% interest in the Jeanette Property, subject to a 1.5% net smelter royalty ("NSR"). The controlling shareholder of 1544230 Ontario Inc. (Perry English) owns 400,000 common shares of the Company which represented 20% of the issued and outstanding shares of the Company at the time the Option Agreement was entered into. Subsequent to the completion of the seed capital equity financings, Mr. English's percentage interest in the issued common shares was reduced to approximately 1.2%.

The option is exercisable by the Company completing a series of cash payments to the Optionors totaling \$80,000, and issuing 400,000 common shares of the Company, to be divided equally between the Optionors, in accordance with the following schedule:

At any time following the exercise of the option to acquire the Jeannette Property pursuant to the terms of the Option Agreement, the Company will have the right to purchase one-third of the NSR from the Optionors at any time for \$500,000, leaving the Optionors with a 1% NSR.

Property Highlights

On August 10, 2023, the Company announced the completion of the June and July 2023 field programs on its Jeannette Lithium Property with plans for an August prospecting program. A crew of two carried out a 7-day field program in June along logging roads which traverse the Property, collecting 16 grab samples. A fly camp was subsequently set up in July on Tarpley Lake for a period of 11 days, during which 29 further grab samples were collected by the crew.

b) Harrison Road Lithium Property

On August 3, 2023, and as amended on January 18, 2024, the Company entered into an Option Agreement with Gravel Ridge Resources Ltd. and 1544230 Ontario Inc. (collectively, the "Optionors"), pursuant to which the Company has the right to acquire a 100% interest in the Harrison Road Lithium Property, subject to a 1.5% net smelter royalty ("NSR"), of which up to one-third may be purchased by way of a one-time payment to the optionors the sum of \$600,000.

The option is exercisable by the Company completing a series of cash payments to the Optionors totaling \$102,000, and issuing 300,000 common shares of the Company, to be divided equally between the Optionors, in accordance with the following schedule:

At any time following the exercise of the option to acquire the Harrison Road Property pursuant to the terms of the Option Agreement, the Company will have the right to purchase one-third of the NSR from the Optionors at any time for \$600,000, leaving the Optionors with a 1% NSR.

(c) Grenfell Gold Property

On June 28, 2023, the Company entered into an Option Agreement with Gravel Ridge Resources Ltd. And 1544230 Ontario Inc. (collectively, the "Optionors"), pursuant to which the Company has the right to acquire a 100% interest in the Grenfell Gold Property, not subject to a net smelter royalty ("NSR").

The option is exercisable by the Company completing a series of cash payments to the Optionors totaling \$58,000, and issuing 300,000 common shares of the Company, to be divided equally between the Optionors, in accordance with the following schedule:

(collectively, the "Optionors"), pursuant to which the Company has the right to acquire a 100% interest in the Marion Gold Property, not subject to a net smelter royalty ("NSR").

(f) Rich Lake Lithium Property

On June 28, 2023, the Company entered into an Option Agreement with Gravel Ridge Resources Ltd. And 1544230 Ontario Inc. (collectively, the "Optionors"), pursuant to which the Company has the right to acquire a 100% interest in the Grenfell Gold Property, not subject to a net smelter royalty ("NSR").

The option is exercisable by the Company completing a series of cash payments to the Optionors totaling \$50,000, and issuing 200,000 common shares of the Company, to be divided equally between the Optionors, in accordance with the following schedule:

A side letter "Letter Agreement" is being entered into in connection with the Grenfell, Rich Lake, Marion and Sheraton option agreements (collectively, the "Options"), each between Planet Green Metals Inc. (as "Optionee"), and Gravel Ridge Resources Ltd. And 1544230 Ontario Inc. (collectively as "Optionors").

The optionors agree with the optionee that, notwithstanding the payment terms set out in Section 4 of each of the Options governing their respective exercise, the Options will be considered to have been exercised according to their respective terms by the payment to the Optionor by the Optionee (which payment does not include the ''Initial Payment'', as that

term is defined in each of the Options), no later than the date which is 8 months following the date of signing of the Options, of the following:

- 1. a cash payment of CAD\$93,000; disbursed 50% to each Optionor and
- 2. the issuance of 650,00 common shares in the capital of the Optionee distributed 50% to each Optionor.

On July 8, 2024, the Company issued 450,000 common shares at fair value of \$0.10 per share to Gravel Ridge Resources Ltd and 1544230 Ontario Inc. pursuant to the Grenfell Property, the Marion Property, the Sheraton Property and the Rich Lake Property option agreements dated June 28, 2024, shares were distributed equally between the optionors.

Shares issued during the three months ended April 30, 2024:

On March 21, 2024, the Company issued 3,127,500 common shares at a fair value of \$0.08 per share.

On March 25, 2024, following the merger between Forza Lithium Corp. and Planet Green Metals Inc.11,300,000 common shares were issued to the shareholders of Planet Green Metals Inc.

During the year ended October 31, 2023, the Company had the following transactions:

On June 27, 2023, the Company finalized its Initial Public Offering (the "IPO") of 5,000,000 common shares at a price of \$0.10 per Share for gross proceeds of \$500,000. Leede Jones Gable Inc. also elected to exercise its over-allotment option in full in connection with the IPO. Pursuant to the Agent's exercise of the Over Allotment Option, the Company has issued an additional 750,000 Shares at a price of \$0.10 per Share for gross proceeds of \$75,000, and 517,500 Agent options to the Underwriter.

The Company has also issued 400,000 common shares to Gravel Ridge Resources, Ltd., a private company controlled by Michael Frymire, and 1544230 Ontario Inc, a private company controlled by Perry English pursuant to the Jeanette Property option agreement dated March 23, 2022, as amended January 9, 2023, made between the Company and the Optionors.

Options granted during the three months ended April 30, 2024:

On July 2, 2024, the Company granted incentive stock options to a consultant to purchase up to 100,000 common shares exercisable on or before July 2, 2029, at an exercise price of \$0.10 per share. The options, with a fair value of \$7,500, options will be vested monthly over the next twelve months at 8,333 options per month with a fair value of \$625. This granted incentive stock options was cancelled in August 2024.

On April 16, 2024, the Board of Directors granted 1,700,000 options in aggregate to directors and officers of the Company at an exercise price of \$0.10, expiring on April 16, 2029, with a fair value of \$127,500.

RELATED PARTY TRANSACTIONS AND BALANCES

Parties are considered to be related if one party has the ability, directly or indirectly, to control the other party or exercise significant influence over the other party in making financial and operating decisions. Related parties may be individuals or corporate entities. A transaction is considered to be a related party transaction when there is a transfer of resources or obligations between related parties. The Company has identified the Directors, President and Chief Executive Officer and the Chief Financial Officer as its key management personnel.

Included in accounts payable as at July 31, 2024 is \$10,279 (October 31, 2023 - \$1,665) owing for services to companies controlled by directors and officers of the Company. These amounts are unsecured, non-interest bearing, and are due on demand.

COMMITMENTS

The Company has a management agreement with a company controlled by a director for management and administrative services in the amount of \$4,000 per month. Either party may terminate this Agreement by giving written notice thereof to the other party. If the Company terminates this agreement, the Company shall provide working notice, payment in lieu of working notice, or a combination thereof, equal to 3 months of the fees.

FINANCIAL INSTRUMENTS AND OTHER INSTRUMENTS

(a) Financial Instruments

As at July 31, 2024, the Company's financial instruments consist of cash and accounts payable and accrued liabilities. As at July 31, 2024, the Company classifies its cash as fair value through profit and loss, and its accounts payable and accrued liabilities as amortized cost. The fair value of accounts payable and accrued liabilities approximates its carrying value because of its current nature. Cash is classified as a Level 1 financial instrument.

(b) Fair Value Measurements

The Company's financial instruments are categorized in a fair value hierarchy that reflects the significance of the inputs used in making the measurements. The fair value hierarchy has the following levels:

Level 1 – Quoted prices are available in active markets for identical assets or liabilities as of the reporting date. Active markets are those in which transactions occur in sufficient frequency and volume to provide pricing information on an ongoing basis. Cash is classified under Level 1.

Level 2 – Fair value measurements are those derived from inputs other than quoted prices that are observable for the asset or liability, either directly (i.e. as prices) or indirectly (derived from prices). The Company does not have any financial instruments classified under Level 2.

Level 3 – Valuations in the level are those with inputs for the asset or liability that are not based on observable market data. The Company does not have any financial instruments classified under Level 3.

During the period ended April 30, 2024, there were no transfers between level 1, level 2 and level 3 classified assets and liabilities.

(a) Credit risk

Credit risk is the risk that one party to a financial instrument will cause a financial loss for the other party by failing to discharge an obligation. Financial instruments which are potentially subject to credit risk for the Company consist primarily of cash. The carrying amount of financial assets represents the maximum credit exposure. The Company has gross credit exposure at July 31, 2024, relating to cash of \$35,263. The cash is held at a Canadian chartered bank and the Company considers the credit risk to be minimal.

(b) Liquidity risk

Liquidity risk is the risk that an entity will encounter difficulty in meeting obligations associated with financial liabilities that are settled by delivering cash or another financial asset. The Company's ability to continue as a going concern is dependent on management's ability to raise the required capital through future equity or debt issuances but there can be no assurance that such financing will be available on a timely basis under terms acceptable to the Company. The Company manages its liquidity risk by forecasting cash flows to be used in operations and anticipating any investing and financing activities. As at July 31, 2024, the Company has a cash balance of \$35,263 to settle its short-term liabilities of \$131,420.

(c) Market Risk

Market risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices. Market risk comprises three types of risk: currency risk, interest rate risk and other price risk

Interest Rate Risk

Interest rate risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market interest rates. The Company has cash balances with interest based on the prime rate. The Company's current policy is to invest excess cash in investment-grade short-term deposit certificates issued by its banking institution. The Company periodically monitors the investments it makes and is satisfied with the credit ratings of its banks.

Other Price Risk

Other price risk is the risk that the fair value or future cash flows of a financial instrument will fluctuate because of changes in market prices (other than those arising from interest rate risk or currency risk), whether those changes are caused by factors specific to the individual financial instrument or its issuer or by factors affecting all similar financial instruments traded in the market. The Company's ability to raise capital to fund exploration or development activities is subject to risks associated with fluctuations in the market price of lithium. The Company closely monitors commodity prices to determine the appropriate course of actions to be taken.

Risks and Uncertainties

Exploration and Development

Exploration for minerals or precious gems is a speculative venture involving substantial risk. There is no certainty that the expenditures made by the Company will result in discoveries of commercial metal reserves.

Mining and development risk always accompany anticipated rewards, and uncertainties always exist where mineral properties are concerned. Uncertainties include the size, grade and recovery of a natural occurring mineral deposit. Although exploration and development efforts can outline a mineral deposit with a degree of certainty, ultimate grade and tonnages are never fully known until mining has been completed.

Metal and prices are also a significant factor in the development decision for a mineral property, as a mine may not be economically feasible in a period of depressed prices. Factors, beyond the control of the Company, may affect the

marketability of any minerals discovered. Pricing is affected by numerous factors such as international economic and political trends, global or regional consumption and demand patterns, and increased production by current producers.

Title Risks

Although the Company has exercised the usual due diligence with respect to determining title to properties in which it has a material interest, there is no guarantee that title to such properties will not be challenged or impugned.

Price Volatility of Public Stock

In recent years, securities markets have experienced extremes in price and volume volatility. The market price of securities of many early-stage companies, among others, have experienced fluctuations in price which may not necessarily be related to the operating performance, underlying asset values or prospects of such companies. It may be anticipated that any market for the Company's shares will be subject to market trends generally and the value of the Company's shares may be affected by such volatility.

Economic Conditions

Unfavourable economic conditions may negatively impact the Company's financial viability as a result of increased financing costs and limited access to capital markets.

Dependence on Management

The Company is very dependent upon the personal efforts and commitment of its existing management. To the extent that management's services would be unavailable for any reason, a disruption to the operations of the Company could result, and other persons would be required to manage and operate Planet Green Metals Inc.

CONFLICTS OF INTEREST

The Company's directors and officers may serve as directors and officers or may be associated with other reporting companies or have significant shareholding in other public companies. To the extent that such other companies may participate in business or asset acquisitions, dispositions, or ventures in which Planet Green Metals Inc. may participate, the directors and officers of the Company may have a conflict of interest in negotiating and concluding terms respecting the transaction. If a conflict of interest arises, Planet Green Metals Inc. will follow the provisions of the Business Corporations Act in dealing with conflicts of interest. These provisions state that where a director/officer has such a conflict, the director must arrange a meeting of the board to disclose his interest and must refrain from voting on the matter unless otherwise permitted by the Corporations Act. In accordance with the laws of the Province of British Columbia, the directors and officers of Planet Green Metals Inc. are required to act honestly, in good faith and in the best interests of the Company.
