Introduction

This Management Discussion and Analysis (this "MD&A") of Questcorp Mining Inc. (the "Company") has been prepared by management in accordance with the requirements of National Instrument 51-102 ("NI 51-102") as of June 26, 2024 and should be read in conjunction with condensed interim financial statements of the Company for the nine months ended April 30, 2024, the audited financial statements of the Company for the year ended July 31, 2023 and the related notes contained therein which have been prepared under International Financial Reporting Standards ("IFRS"). The information contained herein is not a substitute for detailed investigation or analysis on any particular issue. The information provided in this document is not intended to be a comprehensive review of all matters and developments concerning the Company.

All financial information in this MD&A has been prepared in accordance with International Accounting Standards ("IAS") 34, Interim Financial Reporting, and all dollar amounts are quoted in Canadian dollars, the reporting and functional currency of the Company, unless specifically noted.

Overview

The Company is a resource exploration company focused on acquiring and exploring resource properties in Canada.

The Company was incorporated under the laws of British Columbia on April 9, 2021. The head office of the Company is located at Suite 250, 750 West Pender Street, Vancouver, British Columbia, V6C 2T7 and the registered and records office is located at Suite 2200, 885 West Georgia Street, Vancouver, British Columbia, V6C 3E8.

In December 2023, the Company completed its initial public offering and its common shares were listed on the Canadian Securities Exchange on December 11, 2023, under the trading symbol QQQ.

On May 22, 2024, all issued and outstanding common shares of the Company were consolidated on a 2:1 basis. All references to share, option, warrant and per share amounts have been retroactively restated to reflect the share consolidation.

Significant Events for the Period Ended April 30, 2024 and to the Date of This Report

In December 2023, the Company completed its initial public offering by issuing 2,500,000 common shares at \$0.20 per share for gross proceeds of \$500,000. The agent received a cash commission \$50,000 and corporate finance fees of \$25,000 in cash, 50,000 common shares at \$0.20 per share for a value of \$10,000 and 250,000 agent's warrants valued at \$36,154 using the Black Scholes Model, with each agent warrant exercisable for one common share at a price of \$0.20 until December 12, 2025. The Company incurred an additional \$72,741 of cash share issuance costs in relation to the initial public offering.

In June 2024, the Company announced that it intends to complete a non-brokered private placement offering (the "Offering") of 4,999,999 units (each, a "Unit") at a price of \$0.07 per Unit for gross proceeds of \$350,000. Each Unit will consist of one common share of the Company and one common share purchase warrant entitling the holder to acquire a further common share of the Company at a price of \$0.10 per share for a period of two years.

Exploration Activities

North Island Copper Property, BC, Canada

On October 4, 2021, the Company entered into an option agreement to acquire a 100% interest in the North Island Copper Property (the "Property") with a third party. Following the exercise of the option, the Property will remain subject to a 3% net smelter return royalty ("NSR"). The Company may purchase the first 1% of the NSR for \$750,000 and may purchase the remaining 2% of the NSR for an additional \$1,000,000.

Pursuant to the option agreement, the Company is required to complete the following:

- (1) to acquire a 51% interest in the Property, the Company shall pay \$10,000 to the vendor upon the effective date of the Option Agreement (paid);
- (2) to acquire an additional 49% interest in the Property, the Company shall: (i) pay a total of \$85,000 to the vendor; (ii) issue a total of 1,100,000 common shares; and (iii) spend a total of \$500,000 on exploration expenditures on the Property as set out below:
 - (a) the Company shall issue the common shares as follows:
 - (i) 1,000,000 common shares upon the date listed on a Canadian exchange ("Listing Date") (issued);
 - (ii) 50,000 common shares within the first anniversary of the Listing Date;
 - (iii) 25,000 common shares within the second anniversary of the Listing Date; and
 - (iv) 25,000 common shares within third anniversary of the Listing Date,
 - (b) the Company shall pay the cash portion as follows:
 - (i) \$10,000 upon the Listing Date (paid);
 - (ii) \$10,000 on or before the first anniversary of the Listing Date;
 - (iii) \$5,000 on or before the second anniversary of the Listing Date; and
 - (iv) \$60,000 on or before the third anniversary of the Listing Date.
 - (c) the Company shall make the exploration expenditures on the Property according to the following schedule:
 - (i) \$80,000 on or before the first anniversary of the Listing Date (incurred);
 - (ii) \$100,000 on or before the second anniversary of the Listing Date; and
 - (iii) \$320,000 on or before the third anniversary of the Listing Date.

Results for the nine months ended April 30, 2024 and 2023

The net loss for the nine months ended April 30, 2024 was \$345,646 compared to a net loss of \$84,276 for the nine months ended April 30, 2023.

Expenses are made up of:

Accounting and audit fees of \$42,100 (2023 - \$8,000) due to increased audit and tax fees, consulting fees of \$146,250 (2023 - \$40,000) due to the addition of new consultants, legal fees of \$8,715 (2023 - \$26,594), marketing of \$34,706 (2023 - \$nil), office and administration of \$25,384 (2023 - \$3,316), rent of \$9,000 (2023 - \$4,000), shareholder information of \$23,132 (2023 - \$nil), transfer agent and filing fees of \$7,463 (2023 - \$5,564) and travel expenses of \$48,896 (2023 - \$13,670).

Results for the three months ended April 30, 2024 and 2023

The net loss for the three months ended April 30, 2024 was \$148,126 compared to a net loss of \$44,596 for the three months ended April 30, 2023.

Expenses are made up of:

Accounting and audit fees of \$21,750 (2023 - \$nil) due to increased audit and tax fees, consulting fees of \$55,000 (2023 - \$22,500) due to the addition of new consultants, legal fees of \$4,833 (2023 - \$nil), marketing of \$23,307 (2023 - \$nil), office and administration of \$9,604 (2023 - \$2,600), rent of \$3,000 (2023 - \$4,000), shareholder information of \$15,354 (2023 - \$nil), transfer agent and filing fees of \$nil (2023 - \$5,588) and travel expenses of \$15,278 (2023 - \$11,866).

Liquidity and Capital Resources

Cash at April 30, 2024 totaled \$35,665 compared to \$64,325 at July 31, 2023. Working capital at April 30, 2024 was \$16,862 compared to working capital of \$22,501 at July 31, 2023. The ability of the Company to continue as a going-concern depends upon its ability to develop profitable operations and to continue to raise adequate financing.

In December 2023, the Company completed its initial public offering by issuing 2,500,000 common shares at \$0.20 per share for gross proceeds of \$500,000.

Net cash used in operating activities for the period ended April 30, 2024 was \$390,589 compared to \$145,547 used during the same period in the prior year.

Net cash provided by financing activities for the period ended April 30, 2024 was \$371,699 compared to \$230,500 during the same period in the prior year, from shares issued for cash.

Net cash used in investing activities for the period ended April 30, 2024 was \$9,770 compared to \$16,150 during the same period in the prior year, for exploration and evaluation asset expenditures.

Transactions with Related Parties

Key management personnel are the persons responsible for the planning, directing and controlling the activities of the Company and include both executive and non-executive directors, and entities controlled by such persons. During the period ended April 30, 2024, the Company incurred \$67,500 (2023 - \$30,000) in consulting fees and \$9,000 (2023 - \$4,000) in rent to a company controlled by a director of the Company. As at April 30, 2024, there was \$4,335 (July 31, 2023 - \$nil) owing to this company, included in accounts payable and accrued liabilities. These amounts are non-interest bearing with no stated terms of payment.

During the period ended April 30, 2024, the Company incurred \$29,250 (2023 - \$nil) in accounting fees to a firm in which a director is a partner. As at April 30, 2024, there was \$7,088 (July 31, 2023 - \$Nil) owing to this firm, included in accounts payable and accrued liabilities.

During the period ended April 30, 2024 the company incurred \$20,000 (2023 - \$Nil) in consulting fees to a company controlled by a director. As at April 30, 2024, there was \$28,849 (July 31, 2023 - \$Nil) owing to this company, included in accounts payable and accrued liabilities. These amounts are non-interest bearing with no stated terms of payment.

The Company plans to obtain financing upon the completion of its plan of arrangement through debt financing, equity financing, or other means. There is no assurance that the Company will be able to obtain adequate financing or that the terms of such financing will be favorable.

Price Volatility

In recent years securities markets have experienced extremes in price and volume volatility. The market price of securities of many early stage companies, among others, have experienced fluctuations in price which may not necessarily be related to the operating performance, underlying asset values or prospects of such companies. It may be anticipated that any market for the Company's securities will be subject to market trends generally and the value of the Company's securities may be affected by such volatility. In

addition, as the Company's securities are not currently listed on a stock exchange, this may further impact the market for, and value of, the Company's securities.

Economic Conditions

Unfavorable economic conditions may negatively impact the Company's financial viability as a result of increased financing costs and limited access to capital markets.

Dependence on Management

The Company is very dependent upon the personal efforts and commitment of its existing management. To the extent that management's services would be unavailable for any reason, a disruption to the operations of the Company could result, and other persons would be required to manage and operate the Company.

Conflicts of interest

The Company's directors and officers may serve as directors and officers or may be associated with other reporting companies or have significant shareholdings in other public companies. To the extent that such other companies may participate in business or asset acquisitions, dispositions or ventures in which the Company may participate, the directors and officers of the Company may have a conflict of interest in negotiating and concluding terms respecting the transaction. If a conflict of interest arises, the Company will follow the provisions of the BCBCA in dealing with conflicts of interest. These provisions state that where a director/officer has such a conflict, the director must arrange a meeting of the board to disclose his interest and must refrain from voting on the matter unless otherwise permitted by the BCBCA. In accordance with the laws of the Province of British Columbia, the directors and officers of the Company are required to act honestly, in good faith and in the best interests of the Company.
