On April 20, 2023 (the "Effective Date"), Formation Metals issued shares to the shareholders of Usha Resources pursuant to a statutory arrangement under a plan of arrangement (the "Arrangement"). On the Effective Date, Formation Metals became a reporting issuer in the provinces of British Columbia and Alberta.

Substitutional Listing

In accordance with the Arrangement, Usha Resources shareholders who previously held one common share of Usha (the "Old Usha Shares") were issued one new common share of Usha ("New Usha Shares") on a one for one basis. Accordingly, the New Usha Shares were listed on the Exchange at the market opening on Tuesday, April 25, 2023.

Delist

In conjunction with the closing of the Arrangement, the Old Usha Shares were delisted from the Exchange at the close of business on Monday, April 24, 2023.

The Arrangement, as set forth in the arrangement agreement and plan of arrangement dated May 10, 2022 (the "Arrangement Agreement") entered into between the Parties, was approved by the shareholders of Usha Resources on December 16, 2022, by a Final Order granted by the Supreme Court of British Columbia on January 6, 2023, in accordance with Part 9 of the *Business Corporations Act* (British Columbia), and accepted by the TSX Venture Exchange (the "Exchange").
