# MANAGEMENT DISCUSSION FOR EAGLEONE METALS CORPORATION FOR THE NINE MONTHS ENDED JUNE 30, 2024 PREPARED AS OF AUGUST 27, 2024

# Background

This discussion and analysis of financial position and results of operations is prepared as at August 27, 2024 and should be read in conjunction with the interim financial statements for the period ended Junel 30, 2024 and the audited financial statements for the fiscal year ended September 30, 2023 of EagleOne Metals Corporation ("EagleOne" or the "Company"). The interim financial statements have been prepared in accordance with International Financial Reporting Standards ("IFRS"). Except as otherwise disclosed, all dollar figures included therein and the following management discussion and analysis ("MD&A") are quoted in Canadian dollars. #### Overview

EagleOne is engaged in the identification, acquisition, exploration and development of mineral projects.

The Company holds the exclusive option to acquire a 100% interest, subject to a 2% net smelter returns royalty, in the Magusi West property (the "Property"). The Property is located approximately 39 kilometres northwest of the City of Rouyn-Noranda, Quebec and consists of 11 contiguous unpatented mineral claims covering approximately 563.35 hectares.

EagleOne commissioned, and filed via SEDAR+, independent technical report prepared in accordance with National Instrument 43-101 – Standards of Disclosure for Mineral Projects ("NI 43-101") with respect to the Property. The Company intends to complete the Phase I exploration program, as recommended in the

NI 43-101 report, in September and October 2024. The first phase of exploration will consist of surface stripping, line-cutting, geological mapping, and sampling.

#### **Overall Performance**

Because EagleOne is involved in the exploration of mineral properties without any known economic quantities of mineralization, it has not generated any revenue to date and is unlikely to realize revenue in the foreseeable future. Management anticipates that it will incur expenses in connection with the exploration of its mineral property, compliance with applicable securities rules and continuous disclosure requirements, and general and administrative costs.

### **Results of Operations**

In the nine-month period ended June 30, 2024, the Company incurred a net loss of \$114,070 compared to a net loss of \$57,263 during the same period in fiscal 2023. The increase in net loss is primarily due to an increase in professional fees of \$58,366 and transfer agent and filing fees of \$12,114 in connection with the preparation of the Company's prospectus, partially offset by a decrease in general and administrative expenses of \$20,091. The Company anticipates that it will incur increasing expenses in fiscal 2024 as it conducts further exploration of its mineral property interests and complies with its disclosure obligations as a reporting issuer. EagleOne became a reporting issuer in British Columbia, on August 15, 2024 and will become a reporting issuer in Ontario when its shares commence trading on the Canadian Securities Exchange.

# **Summary of Quarterly Results**

EagleOne became a reporting issuer on August 15, 2024. The following is selected financial information from the Company's eight most recent fiscal quarters:

Factors causing significant variations in quarterly results are as follows:

For the three months ended June 30, 2024, the Company incurred a net loss of \$37,780 compared to a net loss of \$35,076 for the three months ended June 30, 2023. The increase in net loss was primarily due to the increase in professional fees of \$31,274, offset by the decrease in general and administrative expenses of

\$20,248 and exploration and evaluation expenditures of \$10,059 during the three months ended June 30, 2024 as compared to the three months ended June 30, 2023.

For the three months ended June 30, 2024, the Company incurred a net loss of \$37,780 compared to a net loss of \$54,540 for the three months ended March 31, 2024. The decrease in net loss was primarily due to the decrease in exploration and evaluation expenditures of \$31,570 and transfer agent and filing fees of \$10,546, offset by an increase in professional fees of \$17,279 and a gain on settlement of below-market interest rate loan of \$7,298 during the three months ended June 30, 2024 as compared to the three months ended March 31, 2024.

For the three months ended March 31, 2024, the Company incurred a net loss of \$54,540 compared to a net loss of \$20,059 for the three months ended March 31, 2023. The increase in net loss was primarily due to the increase in professional fees of \$13,995, transfer agent and filing fees of \$11,330, exploration and evaluation expenditures of \$8,829, partially offset by a gain on settlement of below market interest rate loan of \$7,298 during the three months ended March 31, 2024 as compared to the three months ended March 31, 2023.

For the three months ended March 31, 2024, the Company incurred a net loss of \$54,540 compared to a net loss of \$21,750 for the three months ended December 31, 2023. The increase in net loss was primarily due to the increase in exploration and evaluation expenditures of \$27,774 and transfer agent and filing fees of \$11,330, offset by a gain on settlement of below market interest rate loan of \$7,298 during the three months ended March 31, 2024 as compared to the three months ended December 31, 2023.

For the three months ended December 31, 2023, the Company incurred a net loss of \$21,750 compared to a net loss of \$2,128 for the three months ended December 31, 2022. The increase in net loss was primarily due to the increase in professional fees of \$13,097 and exploration and evaluation expenditures of \$8,518 during the three months ended December 31, 2023 as compared to the three months ended December 31, 2022.

For the three months ended December 31, 2023, the Company incurred a net loss of \$21,750 compared to a net loss of \$70,425 for the three months ended September 30, 2023. The decrease in net loss was primarily due to the decrease in exploration and evaluation expenditures of \$54,754, offset by the increase in professional fees of \$11,022 during the three months ended December 31, 2023 as compared to the three months ended September 30, 2023.

#### **Liquidity and Capital Resources**

As at June 30, 2024, the Company had current assets of \$241,879 and current liabilities of \$31,491, resulting in a working capital of \$210,388. Total shareholders' equity was \$186,509 as at June 30, 2024.

As EagleOne will not generate funds from operations for the foreseeable future, the Company is primarily reliant upon the sale of equity securities in order to fund operations. Since inception, the Company has funded limited operations through the issuance of equity securities on a private placement basis. This has allowed the Company to carry out limited exploration and commission a geological report for the Magusi West property.

The Company will require \$50,000 to make the property option payment that will be due on December 31, 2024 respecting the Magusi West property. The Company also anticipates spending \$50,000 to cover anticipated general and administrative costs and legal, audit, and office overhead expenses for the next 12-month period. At June 30, 2024, the Company had cash of \$241,879, which is sufficient to cover all expected exploration, operations, and administrative expenses for the next twelve months. However, the Company

cannot offer any assurance that expenses will not exceed management's expectations and the Company may require additional funds and will be dependent upon its ability to secure equity and/or debt financing, the availability of which cannot be assured. These factors indicate the existence of a material uncertainty that may cast significant doubt on the Company's ability to continue as a going concern.

Although the Company currently has limited capital resources, the Company anticipates that additional funding will come from equity financing from the sale of the Company's shares or through debt financing. The Company may also seek loans. It may also receive proceeds from the exercise of outstanding share purchase warrants and stock options. While the Company has been successful in securing financings in the past, there is no assurance that it will be able to obtain adequate financing in the future or that such financing will be available on acceptable terms.

#### **Off Balance Sheet Arrangements**

The Company does not have any off-balance sheet arrangements.

#### **Management and Related Party Transactions**

The Company's Board of Directors consists of Matthew Markin, Barry Wattenberg, Howard Blank, and Robert Reukl. Matthew Markin acts as President, Chief Executive Officer and Secretary, and Barry Wattenberg acts as Chief Financial Officer of the Company.

As at June 30, 2024, the Company owed to the president of the Company for advances of \$410 (September 30, 2023 - \$410). The amount is unsecured, non-interest bearing and due on demand.

On March 21, 2024, the Company entered into a Promissory Note with the president of the Company for a principal amount of \$30,000. The note is unsecured, non-interest bearing and is due for repayment on September 30, 2025. The Company recognized a gain of \$7,298 and a corresponding discount upon the issuance of a below-market interest rate promissory note to a related party. The carrying value of the promissory note will be accreted to the face value of \$30,000 over the term of the note. During the nine months ended June 30, 2024, the company recognized accretion expense of \$1,177. As at June 30, 2024, the carrying value of the promissory note was \$23,879 (September 30, 2023 - \$Nil).

# **Critical Accounting Estimates**

The preparation of the Company's consolidated financial statements in conformity with IFRS requires management to make judgments, estimates and assumptions that affect the application of accounting policies and reported amounts of assets, liabilities, revenues and expenses. By their nature, estimates are subject to measurement uncertainty and changes in such estimates in future periods could require a material change in the financial statements. Accordingly, actual results may differ from these estimates. Estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognized in the period in which the estimate is revised and in any future periods affected.

Significant areas requiring the use of estimates include preparing the financial statements on a going concern basis fair value of share-based payments. Actual results could differ from those estimates.

Judgments made by management include the factors used to determine the assessment of whether the going concern assumption is appropriate. The assessment of the going concern assumption requires management to take into account all available information about the future, which is at least, but is not limited to, 12 months from the end of the reporting period. The Company is aware that material uncertainties related to events or conditions may cast significant doubt upon the Company's ability to continue as a going concern.

#### **Disclosure of Outstanding Security Data**

#### Common Shares

As at June 30, 2024, the Company had 2,250,000 common shares issued and outstanding. As of the date of this MD&A, the Company had 9,703,000 common shares issued and outstanding, which reflects the deemed exercise of 4,800,000 Series "A" special warrants and 2,653,000 Series "B" special warrants that were qualified by the Company's prospectus.

#### Escrow Shares

As at June 30, 2024 and this MD&A, the Company had 2,250,000 of its common shares held in escrow, which are all held by the Company's directors and officers.

### Stock Options

As at June 30, 2024, and the date of this MD&A, the Company had 970,000 options issued and outstanding, which are exercisable for \$0.10 each for a period of ten years from the date the Company's shares commence trading on the Canadian Securities Exchange.

#### Share Purchase Warrants

As at June 30, 2024, the Company did not have any share purchase warrants outstanding. As of the date of this MD&A, the Company has 4,800,000 common share purchase warrants outstanding. Each warrant is exercisable into one common share of the Company for \$0.10 until five years from the date the Company's shares commence trading on the Canadian Securities Exchange.

# Additional Disclosure for Venture Issuers without Significant Revenue

During the three-month period ended June 30, 2024, the Company incurred general and administrative expenses of \$72, which was entirely comprised of bank charges.
